### 1. Exhibitor Package

#### 1.1 Space

The exhibition hall is located in the lobby of the Conference Hotel (<u>VidaMar Resorts</u>), near the main entrance/reception and the business centre, in the access to the conference room.

All exhibitors who wish to attend this conference must be registered and lodged in the Conference Hotel as a normal participant (Participant registration not included).

<sup>\*</sup>Only space is offered. The exhibitors are responsible for the assembling (16 of November in the afternoon) and removing (not after the 21 of November in the afternoon) of the upright structure. They should use their own stand which must not damage the floor of the exhibition Hall.

#### 1.2 Office Equipment Cost

## 1.3 Special Exhibitor Package: 550 euros

### 2.1 Corporate Basic Package (CBP): 450 euros
